Jury

Frost PTSA Craft Show Committee will be the sole judge of admissibility and reserves the right to exclude any exhibit or part thereof. A limited number of crafters in each category will be accepted to maintain a good balance and fair representation.

Booth Assignments

Exhibit spaces are filled in order applications are received with full payment. Booth locations cannot be guaranteed, however requests will be prioritized for returning crafter applications received by May 29, 2020.

- *Fees include floor space and 1 chair.
- ***Bring your own tables.**
- *Late registration fee is \$10 for applications received after **August 15, 2020**

- *Submit 3 or more photos of your work & 2 photos of your display.
- *Print your name on each photo
- *Include photos of each media you intend to display and a self-addressed, stamped envelope for photo returns.
- *Include check or money order payable to Frost PTSA Craft Show.

No applications for new crafters will be considered without photos. Returning crafters from the prior year only need to submit photos if they have display changes or new items they wish to sell.

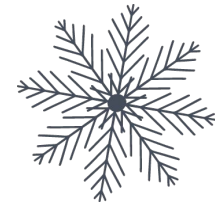
