We are happy to provide an update to you on the latest information regarding our Return to Learn plan following the Safe Start September remote start to the 2020-21 school year.

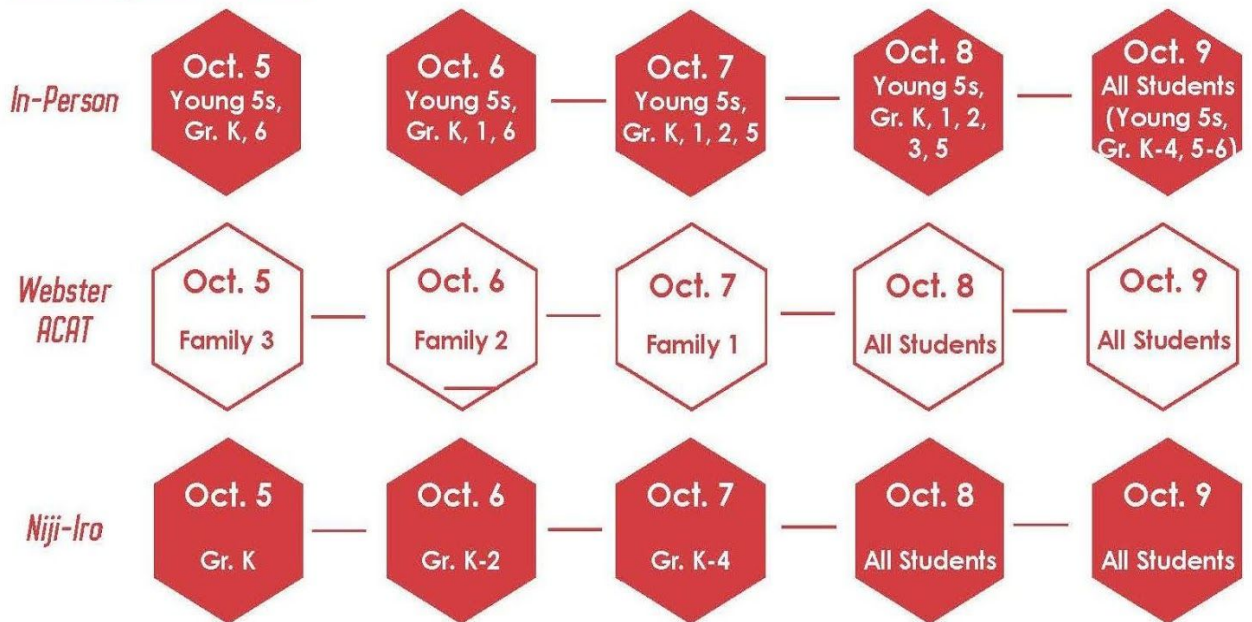
The LPS Board of Education, last evening, voted 7-0 in favor of returning to in-person instruction, beginning in a phased manner on Monday, October 5.

To assist our school teams in preparing for October 5, this Friday, October 2, will be a self-guided (asynchronous) day of learning for all students (including Livonia Virtual students). There will be no live instruction on this day.

Below are the schedules for the return to in-person instruction, by level, and the daily time schedules. Please keep this handy, as we approach next week. If you have questions, please feel free to contact your child's school secretary by dialing the main office.

Elementary Transition Plan



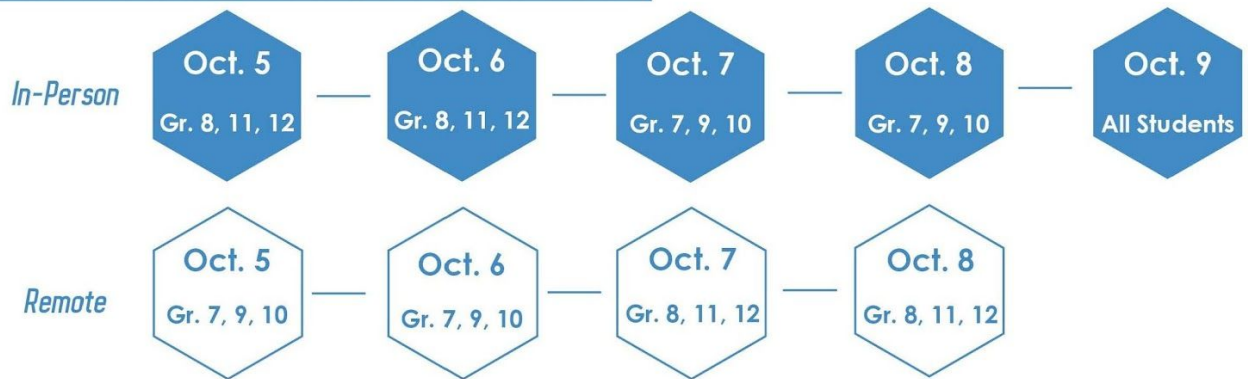
Learning continues for all; students who are not in-person will continue on their remote learning schedules.

Stevenson - Start time: 8:10 a.m. / Dismissal: 1:55 p.m.

Franklin - Start time: 8:10 a.m. / Dismissal: 1:55 p.m.

LCTC - Start time: 8:15 a.m. / Dismissal: 1:40 p.m.

Drop-offs no earlier than 25 minutes prior to start time.

Students will continue their current remote schedule when not in person.

Transition Plan: Special Education

Pre-K - Post-Secondary Full Time RCR & Center-Based Programs

Week of October 4

- **Special Education plan is modeled after the general education plan:**
 - **Return is full day: Based on grade level or student/district**
 - **Monday / Tuesday group and Wednesday / Thursday group**
 - **The specific plan for each program will be communicated with families.**

Following the week of October 5, all students will attend full-day, in-person, five days per week. Block schedules at the middle and high school levels will continue throughout the school year.
